The National Academy of Inventors® (NAI) recognizes, encourages, and enhances visibility of academic inventors with patents issued from the U.S. Patent and Trademark Office. As a 501(c)(3) non-profit organization, we are comprised of Member Institutions including more than 200 U.S. and international universities, governmental and non-profit research institutes and over 3,000 individual inventor members and Fellows. Together, we serve the public need as experts in investigating, researching, reviewing and providing reports on subjects related to innovation, intellectual property, and translational research.

- NAI Fellowship is the highest professional distinction accorded solely to academic inventors who have demonstrated
 a prolific spirit of innovation in creating or facilitating outstanding inventions that have made a tangible impact on
 quality of life, economic development, and the welfare of society. NAI Fellows have generated more than 8,500
 licensed technologies and companies and created more than 1.1 million jobs.
- H.R. 976 has been introduced to grant a Federal charter to the NAI. This legislation would federally recognize the importance of the NAI's mission, goals and objectives, in bettering the welfare of society. The bill would also allow NAI members to be called upon as subject matter experts by any department of the government.
- Sample NAI publications include the *Top 100 Worldwide Universities Granted U.S. Utility Patents* in collaboration with the IPO each year, and the multidisciplinary journal *Technology and Innovation*, which serves as a forum for presenting information on applied sciences, with a focus on transformative technology and academic innovation.
